PERSONAL INFORMATION DIRECTORY

Under Section 69(6) of the Freedom of Information and Protection of Privacy Act ("Act"), public bodies are required to create and maintain a PID which lists the specific collections of personal information maintained by the public body.

A personal information bank is defined in the legislation as "a collection of personal information that is organized or retrievable by the name of an individual or by an identifying number, symbol or other particular assigned to an individual".

School District 84 maintains a PID that lists all of the "personal information banks" that are maintained by the District subject to the Act. Personal information includes any recorded information about an identifiable individual other than business contact information and includes an individual's name, personal contact information, and educational and employment history. This PID is available to the public and sets out the following information about each personal information bank:

- title and location;
- description of the kind of personal information and categories of individuals whose personal information is included;
- the authority for collecting the personal information;
- the purposes for which the personal information was obtained or compiled and the purposes for which it is used or disclosed by SD 84;
- the categories of persons who use the personal information or to whom it is disclosed.
